AGREEMENT

for the implementation of the transnational School-Work Alternation experience in Opatija envisaged by the "EuroGiacinto 2025" Project - 10.6.6B-FSEPON-VE-2024-34

BETWEEN

IT IS AGREED AS FOLLOWS

Art. 1

1. ITET GIRARDI and Međunarodna srednja škola Adria are committed to jointly designing and implementing the transnational School-Work Alternation experience for the selected students, as provided for by the Public Notice "*Paths for transversal skills and orientation (PCTO) abroad*" prot. 136505 del 9/10/2024 and by the Girardi Project called "EuroGiacinto 2025".

2. The Međunarodna srednja škola Adria undertakes to search for and select the host structures for the company visits and collaborate in the definition of the training project according to the characteristics of the candidate (language level of the participant, type of studies carried out, maturity of the candidate), free of charge.

Art. 2

1. The transnational School-Work Alternation activity is jointly designed and verified by a teacher designated by Girardi, called "school tutor", and by an expert identified by Međunarodna srednja škola Adria, called "company tutor".
2. An individualized training course is prepared for each student, which is an integral part of this Agreement, in which the activities to be carried out and the skills to be acquired are described.

Art. 3

1. The company tutor, equipped with adequate experience and professional competence, performs the following functions:
 - a) collaborates with the school tutor in the design, implementation and evaluation of the experience of transnational School-Work Alternation;
 - b) promotes the student's preparation for the projects and the visits in the host structures, supports and assists him/her;
 - c) guarantees the information and training of the student about the host structures, its procedures and its safety risks;
 - d) fills in the sections of his/her competence on the GPU Portal and on the Girardi online electronic register, and signs the daily attendance sheet with the support of the School tutor.
2. The company tutor is paid the remuneration provided for by Notice 136505, i.e. € 1,800.00 gross state for each group of 15 students.

Art. 4

1. Girardi insures the student beneficiary of the PCTO against accidents at work with INAIL, as well as for civil liability with the insurance company Ambiente Scuola.

Art. 5

1. The host facility:
 - a) guarantees the beneficiary student, through the company tutor, the assistance and training necessary for the success of the activity;
 - b) complies with safety regulations in the workplace;
 - c) informs Istituto Girardi of any incident that happens to the beneficiary student.

Art. 6

1. This Agreement shall commence from the date of signing and expire on 31 March 2025, the natural deadline for the conclusion of the "EuroGiacinto 2025" Project as provided for in Notice 136505.

Art. 7

1. The Parties undertake to comply with EU Regulation 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data.
2. The Parties respectively undertake to process personal data, including by electronic means, exclusively for the purposes related to the performance of this Convention.
